CONDITIONS OF CONTRACT FOR BOARDING

1. All animals boarded or cared for by us are accepted on the following terms and conditions:
2. All animals to be 4 months or over and to be fully vaccinated. No animals will be accepted without a vaccination certificate from a veterinary surgeon.
3. If the animal requires veterinary attention, the owners are liable for all costs and out of pocket expenses. In the event of serious illness or accident and the owner cannot be contacted, the veterinary surgeon's decision relating to the treatment of the animal will be final.
4. Animals not collected within 14 days of the specified date will be disposed of at the discretion of this Boarding

Establishment. All monies owing, including fees and costs relating to the disposal, are payable by the owner immediately upon receipt of invoice from this establishment.

5. Should the customer default in the payment of any monies due, under this agreement then all monies due to this Boarding Establishment shall immediately become due and payable and shall be paid by the customer within seven (7) days of the date of demand and this Boarding Establishment shall be entitled to charge interest at the rate of 15 per centum per annum on all overdue accounts from the due date until the date of actual payment.
6. Any expenses, costs or disbursements incurred by this Boarding Establishment in recovering or attempting to recover any outstanding monies including Debit Collection Agency fees and Solicitors costs shall be paid by the customer, providing that those fees do not exceed the scale of charges as charged by that Debt Collection Agency/Solicitor and in any event the commission is not to exceed 18 per centum per annum of the debt value, plus out of pocket expenses.
7. If animals are boarded for more than two (2) weeks, 50% of the boarding fee must be paid in advance.
8. Our Boarding Establishment reserves the right to refuse any animal and no reason shall be given.
9. **Minimum charge two (2) calendar days. Boarding rates are charged on a calendar day basis irrespective of the time of admission or departure and does not include bathing grooming or additional services.**
10. **The fully booked period will be charged during school holidays.**
11. The owner agrees to pay the rate for boarding in effect on the day the animal is checked into our Boarding Establishment.
12. The owner agrees to pay all costs and charges for special service requests and all veterinary costs for the animal during the time the said animal is in our care.
13. The owner agrees to be solely responsible for any and all things done by the animal howsoever resulting while the animals is in the care or our Boarding Establishment including actions or things done while the animal is under our direct supervision or a member of our staff or a subcontractor or any other person engaged by this Boarding Establishment. The owner will pay to this Boarding Establishment all expenses of and for any liability incurred by this Boarding Establishment by reason of the animal's nature, temperament, behavior or actions while the animal is in our care including any cost loss and expense arising out of financial liability resulting from the behavior of the animal.
14. The owner specifically represent that he/she is the sole owner of the animal free and clear of liens and encumbrances.
15. All charges incurred by the owner must be paid before the animal leaves this Boarding Establishment or its Agency.
16. The owner releases this Boarding Establishment and its employees or agents from all liability for injury, death, loss of damage of any kind whatsoever that may occur to any animal in the care of or staying at this Boarding facility including injury, death or loss of damage while under the supervision of this Boarding Establishment its staff, agents or subcontractors.
17. By signing the conditions of contract and leaving his/her animal with this Boarding Establishment the owner warrants the accuracy of all information given about the animal. The owner acknowledges that the signing of the contract shall create a lien over the animal in favor of this Boarding Establishment which lien shall continue to exist whilst ever monies are owing pursuant to the contract.

I acknowledge that I have read the above conditions of contract for boarding my animal with Noblestarzz (Ambre Smith) and that the terms and conditions set out above and on the face of this document apply and will regulate my contract for the care of my animal by Noblestarzz (Ambre Smith) and that all the terms of my contract with Noblestarzz (Ambre Smith) are set out in this contract and I cannot rely on any earlier contract or on any statements made in negotiations leading to my entering into this contract.
